To Whom It May Concern:

In consideration of my desire to participate in the television series currently entitled “\_\_\_\_\_” (“Program”), I hereby irrevocably grant to you, your successors and assigns, the right to record my likeness (including, without limitation, any still photographs, artistic or creative renderings or caricatures, normal actions, gestures, and facial expressions), name (including, without limitation, any professional name or sobriquet) and/or voice (including, without limitation, my speaking, singing and/or musical performance) (collectively, “Likeness”) on videotape, film or any other audio and/or visual medium; to edit such Likeness at your discretion; to incorporate the same into the Program, and to use or authorize the use of my Likeness in connection with the production, exhibition and exploitation of the Program (or any portion thereof) and all ancillary rights therein, in all media, now known or hereafter devised, throughout the universe in perpetuity and in connection with advertising, publicizing and promotion of the Program, Comedy Partners’ programming services or program operations and activities and those of its licensees in any media, now known or hereafter devised. I agree that you shall be the exclusive owner of all copyright and other rights in and to the Program, my Likeness, and any excerpts therefrom, and that you will have the exclusive right to use, and license or otherwise authorize others to use, them, in any manner you wish and in any and all media now known or hereafter devised, throughout the universe in perpetuity.

I hereby release, indemnify and hold harmless you and your parent company, and the respective partners, divisions, subsidiary and affiliated divisions and companies, distributors, assignees, licensees and affiliates, and the respective shareholders, directors, officers, employees and agents of the foregoing, from any and all claims, demands, liabilities, costs and expenses (including, without limitation, reasonable attorneys’ fees and court costs) arising from the use of my Likeness and the use of ideas or words expressed by me in the Program or acts done by me in connection therewith. In the event of any question of your performance of your obligations, I agree that I shall not seek injunctive relief against you (and/or your assignee(s)), and that my relief in such circumstances will be limited to a claim for monetary damages.

New York law governs this agreement. Any litigation, action or proceeding ensuing out of or relating to this release shall be instituted in a court of competent jurisdiction (whether state or federal) in the City of New York and County of New York. You may transfer and assign this agreement or all or any of its rights or privileges hereunder to any entity or individual without restriction. This release shall be binding on all of my successors-in-interest and heirs. I consent to service of process by registered mail, return–receipt requested at the address stated below. This is the complete and binding agreement between Producer and me, and it supersedes all prior understandings and/or communications, both oral and written, with respect to its subject matter.
